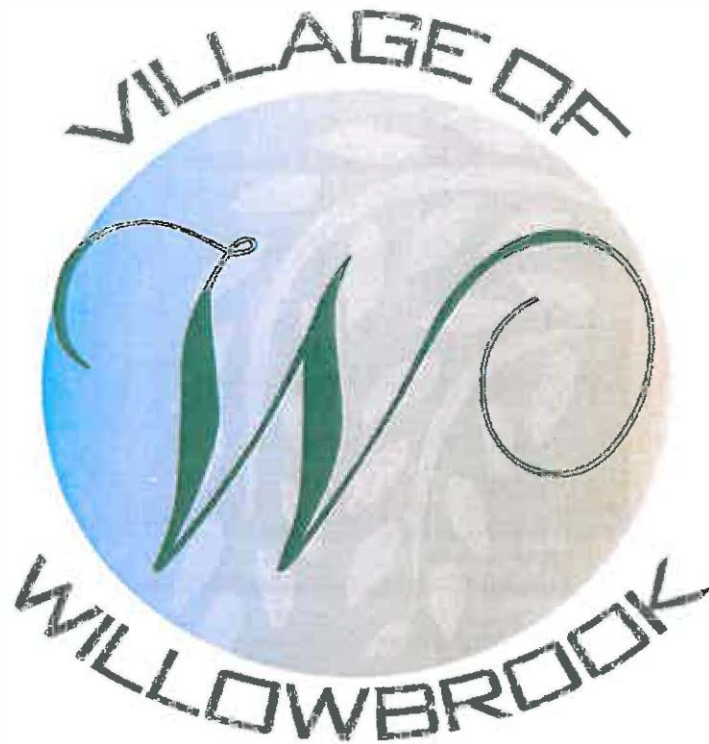

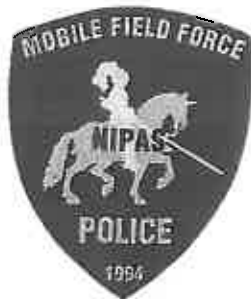

Each year, **7-Eleven, Inc.** helps thousands of local police officers recognize the good guys, specifically the young ones.
