On October 2nd, 2019 at approximately 4:00am, Officer Silva, Officer Edrmann, and Officer Huntley were dispatched to an Ambulance Assist at 6340 Americana Drive for a possible overdose. Upon arrival, Officers Huntley and Erdmann located the unresponsive victim, in a vehicle in the parking garage. Officers Huntley and Erdmann then administered multiple doses of NARCAN while Officer Silva directed Tri State paramedics to the victim's location. Ultimately the victim regained consciousness and was transported to the hospital for treatment. During the incident, 11 baggies of suspected Heroin were recovered and placed into evidence pending further charges.

Officers Silva, Erdmann, and Huntley should be recognized for their teamwork and quick action in this emergency situation. Their diligence in providing an extraordinary level of service to the Citizens of the Village of Willowbrook should be commended.

Wednesday October 16th, 2019 at approximately 1:24am, Officer Esqueda conducted a traffic stop on a silver Buick that was being driven in an erratic manner. Upon making contact with the driver, Officer Esqueda detected a strong odor of cannabis coming from the vehicle. While questioning the driver, he admitted to having a handgun in his pants leg. Subsequent search of the vehicle led to the recovery of the handgun along with a baggie of miscellaneous colored pills in the driver's pants pocket. The driver was then safely taken into custody by Officer Esqueda, Officer Silva, and Sergeant Eisenbeis.

During the follow up investigation, a search was run on the recovered handgun and it was determined to be reported as stolen out of Indiana. Also, field testing was completed on the pills recovered which tested positive for Methamphetamine. Ultimately the driver was charged with multiple felony counts of Aggravated Unlawful Use of a Weapon and Possession of a Controlled Substance.

Officer Esqueda, Officer Silva, and Sergeant Eisenbeis should be recognized for their teamwork and attention to detail. Their diligence and hard work in seeing this case through until the end, lead to an illegally possessed firearm and a controlled substance being taken off of the streets of Willowbrook.
