Willowbrook Police Department Releases Thanksgiving Enforcement Numbers

Willowbrook, IL – Willowbrook Police Department issued 2 seat belt citations and 19 other citations, including 2 traffic arrests during the recent Thanksgiving enforcement effort.

Law enforcement agencies throughout Illinois participated in this effort to reduce highway fatalities by getting impaired drivers off the roads and more people buckled up. The enforcement campaign took place from Nov. 20-30.

During the mobilization, extra emphasis was placed on enforcement during late-night hours, when statistics show the most unbuckled and impaired driving fatalities occur.

The Thanksgiving enforcement effort is made possible by federal traffic safety funds administered by the Illinois Department of Transportation as part of the statewide *Drive Sober or Get Pulled Over* and *Click It or Ticket* campaigns.

This holiday season, stay off the naughty list: drive sober

Willowbrook, IL — The **Willowbrook Police Department** is partnering with the Illinois Department of Transportation and law enforcement throughout the state for a high-visibility enforcement campaign to crack down on impaired driving during the winter holidays. From Dec. 18 to Jan. 4, motorists will see an increase in patrols and traffic stops, along with additional messaging on the dangers of driving impaired.

During this season of caring, let us remember to extend our goodwill to fellow motorists. The best way we can do that is by making a commitment to drive sober and thereby help ensure that we all make it to our destinations safely.

The Willowbrook Police Department recommends these safe alternatives to driving impaired:

- Plan ahead for a sober ride home. Designate a sober driver, take public transportation, or use a ride-sharing service.
- If you are with a friend or family member who intends to drive impaired, take their keys away and make arrangements to get them home safely.
- Always buckle up! It is your best defense against impaired drivers.

The Illinois *Drive Sober or Get Pulled Over* campaign is administered by IDOT with federal highway safety funds managed by the National Highway Traffic Safety Administration.

On December 11th, 2020 at approximately 12:30am, Officer Dillon, Officer Lavalley, Officer Porter, and Officer Erdmann were dispatched to a domestic battery incident at a private residence. Upon arrival, Officer Porter located the suspect who was lying down on the deck and appeared to be convulsing. The suspect's father yelled to Officer Porter that his son sustained an injury from some broken glass and was losing a lot of blood. Officer Porter then returned to his patrol vehicle to obtain first aid supplies. Upon his return, Officer Porter observed the subject to have a large wound to the left bicep area which was spurting blood. From his training and experience, Officer Porter recognized that this type of wound was consistent with an arterial bleed and needed more than just direct pressure to avoid major blood loss. Officer Porter applied a tourniquet to the suspect's injured arm and kept him engaged and awake while awaiting assistance. Officers Erdmann, Lavalley, and Dillon then arrived on the scene and a second tourniquet was applied by Officer Lavalley as the subject was continuing to go in and out of consciousness. The officers then continued administering first aid until Tri-State Fire Protection District arrived and took over care of the victim.
