### **Willowbrook Police Department Releases Fourth of July Enforcement Numbers**

**Willowbrook, Illinois—** The Willowbrook Police Department made one impaired driving arrest, issued 14 seat belt citations, and issued 36 other citations during the Fourth of July “Drive Sober or Get Pulled Over” and “Click it or Ticket” campaigns.

**The Willowbrook Police Department** joined forces with more than 200 other local law enforcement agencies from June 17 through July 6 to get drunk and drugged drivers off our roads and encourage seat belt use. The effort featured high-visibility enforcement combined with a variety of outreach activities, including a media campaign.

The enforcement period was funded by federal traffic safety funds administered by the Illinois Department of Transportation as part of the statewide “Drive Sober or Get Pulled Over” and “Click It or Ticket” programs.

On June 8<sup>th</sup>, 2021, Willowbrook officers were dispatched to an ambulance assist for a possible overdose, at a local hotel. Upon arrival, Sergeant Strugala was directed towards a male lying in the grass who had taken an unknown pill. Sergeant Strugala checked the victim for responsiveness and immediately began Cardiopulmonary Resuscitation (CPR) on the unresponsive victim. Officer Silva arrived on scene with additional supplies and assisted Sergeant Strugala until Tri State Fire Protection District arrived on scene and took over care of the victim.

Sergeant Strugala and Officer Silva should all be recognized for their quick action and teamwork during this emergency response. Their diligence in providing an extraordinary level of service to the Citizens of the Village of Willowbrook should be commended.

### BACKGROUND

Currently the Willowbrook Police Department is utilizing Fuji and Trek police bikes that are more than 10 years old. These patrol bikes have reached their end-of-life cycle. Research was conducted and the Recon Commando battery powered police bike was the best fit for the department due to the following points:

- Safety – An officer can travel a significant distance quickly and not be fatigued on arrival to a scene.
- Coverage – The power bike boost from an electric motor, allows officers to expand their patrol area and cover more ground.
- Mobility – They can maneuver through tight areas, crowds and nearly any terrain.
- Speed – When needed officers can increase their level of pedal assist and quickly get up to 30 mph.
- Strength – Officers arrive stronger. The boost from the motor allows officers to arrive on scene less fatigued. They spend less energy pedaling and more energy policing.
- Functionality – Nearly any Officer can ride a Power Bike; The power assist can be used as little or as much as desired, but when circumstances dictate, the option exists to kick in the power and get there fast.
- 4" Tires –Puncture resistant molded in liner. Super comfortable ride.
- Approach-ability – Both kids and adults that may never approach a squad car, but will greet an officer on a bike. The Power Bikes generate extra interest and an ice breaker.
- Cost Effectiveness – Power Bikes offer all these advantages at a cost not much higher than a standard mountain bike with all the additional benefits. Maintenance costs are similar to a standard mountain bike.

On 7-13-2021 Ofc Opacian and WBPD units was dispatched to Target for a child having a seizure. (21-8728) Ofc Opacian located a family (mother, father, 1-2 year old male child and 4 year old female child) in the parking lot. The female child was breathing, but unconscious. The child was determined to have several serious health issues in her present and past, currently the parents were calling this episode a "seizure". Ofc Opacian stayed with the family until TSFD arrived to attend to the child. The child was transported by TSFD to Hinsdale and eventually Lurie Hospital for care and treatment. Ofc Biggs, Walega, Dillon and myself were on scene for support, but Ofc Opacian was "in charge".

On 7-14-2021 Ofc Opacian approached myself and requested permission and/or procedure for obtaining and presenting a small gift and card to the young 4 year old who was the medical victim of this incident. Ofc Opacian was willing to go to Target and purchase a small gift and card with his own funds. I directed Opacian to DC Kaspar as I believed we had items for this type of gift on hand.

With DC Kaspar's assistance, Ofc Opacian was able to prepare a small gift basket and he purchased a card and small gift from Target, who also provided a small discount, based on the circumstances. Ofc Chavez-Jimenez provided a \$2 bill for "good luck", that was included in the card.

Ofc Opacian, along with Ofcs Biggs and Walega, and Det Robles (who provided her knowledge of the Lurie procedures), went to Lurie Hospital to provide the present to the family/child and wish her well from the WBPD.

Ofc Opacian should be commended for taking the time and effort to care for a small child and her family that will apparently need more care and concern throughout her life.
