1. CALL TO ORDER

The meeting was called to order at 6:32 P.M. by Mayor Frank Trilla.

7. RESOLUTION NO. 21-R-50 - A Resolution Of The Village Of Willowbrook Approving And Authorizing The Execution Of An Agreement With Engineering Solutions Team Co., Inc. To Provide Owner's Representative Services To The Village Of Willowbrook For The Renovation Of The Willowbrook Community Resource Center (ADOPT)

Administrator Pabst shared, in 2018, the Village Board awarded a professional service contract to N. Batistich, Architects, for architectural design and permit services to complete Phase 1 of the Community Resource Center building located at 825 Midway Drive. The proposed project delivery method for the Community Resource Center is an Owner's Representative (OR). The OR is a project delivery method that requires a commitment by the Owner's Representative to manage the general contractor with a Guaranteed Maximum Price (GMP). This is based on construction documents and specifications at the time the GMP is prepared. The OR provides professional services and acts as a consultant to the owner in the design development and construction phases. In addition to acting in the owner's interest, the OR must engage and manage the general contractor. Any costs exceeding the GMP that are not change orders are the financial liability of the selected general contractor. On May 17, 2021, Village staff reviewed three (3) proposals. All three firms were interviewed by representatives from Public Works and the Village Administrator's Office. After the interviews were completed, staff recommended Engineering Solutions Team (EST) unanimously to award the contract. EST has significant project management experience, including the recently constructed Downers Grove Township Community Center. Personnel assigned to the project by EST are well versed in all phases of municipal operations. The firm has also been hired by the Downers Grove Township and the Flag Creek Sanitary District for ongoing projects and as-needed services. The firm that has the lowest bid was Engineering Solutions Team.

8. RESOLUTION NO. 21-R-51 - A Resolution Authorizing Parvin-Clauss Sign Company, Inc. To Develop Village Gateway Signage Concepts And Renderings (ADOPT)

Assistant Administrator Halloran stated at the March 15, 2021 budget workshop meeting, the Board gave direction to staff regarding the location and design of the gateway signage. Following that meeting, staff has been working with neighboring

municipalities with installed gateway signage in the state right-of-way. These discussions with other municipal agencies have informed staff of the type of gateway signage that can be approved and installed in the state right-of-way. On June 28, 2021, the Village received one (1) proposal from Parvin Clauss Sign Company Inc.

Parvin Clauss Sign Company has worked with municipalities for several years and has extensive experience with IDOT. If this contract is approved, staff plans to begin design work with Parvin Clauss Sign Company and will brief the Board of Trustees at the next meeting with different signage options throughout the Village.

Trustee Neal commented that she was very happy to see this moving forward.

Trustee Davi questioned are these the two main signs on 83?

Assistant Administrator Halloran commented the design and locations haven't been finalized and will need final Board approval.

MINUTES OF A SPECIAL BOARD MEETING OF THE VILLAGE OF WILLOWBROOK HELD ON MONDAY, JULY 12, 2021 AT 5:30 P.M. IN THE VILLAGE HALL, 7760 QUINCY STREET, IN THE VILLAGE OF WILLOWBROOK, DUPAGE COUNTY, ILLINOIS.

**1. CALL TO ORDER**

The meeting was called to order by Mayor Trilla at 5:30 p.m.

**2. ROLL CALL**

Those present at roll call were Mayor Frank Trilla, Trustees Sue Berglund, Umberto Davi, Mike Mistele, Gayle Neal, Greg Oggerino and Paul Ruffolo, Village Administrator Brian Pabst, Assistant Village Administrator Sean Halloran, Finance Director Carrie Dittman, Police Chief Robert Schaller, Parks and Recreation Manager John Fenske, and Building Inspector Roy Giuntoli.

Present via Zoom: Deputy Police Chief Lauren Kaspar and Municipal Services Foreman AJ Passero.

**3. REPORT – Managed IT Services RFP Update**

Finance Director Dittman began by explaining the Village's past and current IT services.

For over 15 years, the Village has utilized the services of PCS International to provide outsourced managed Information Technology (IT) services instead of hiring a Village employee to provide those services. Over time, the staff assigned to the Village account has turned over and in light of recent cyber-attacks on the Village in March 2020 and May 2021, the Village has been considering obtaining a new firm that can 1) perform the required services at a cost-effective rate, and 2) implement the suggestions noted by Halock Security Labs in their cyber security reports to mitigate the risk of a future attack.

On May 10, 2021, the Village Board approved a contract with Sikich LLP to assist the Village with drafting a Request for Proposal (RFP) to solicit a qualified technology firm (attached). The RFP was sent out today, July 12<sup>th</sup>, to 12 firms and a conference call of interested parties will be held on Monday, July 19<sup>th</sup>.

Responses will be due approximately two weeks later, and interviews with finalist firms will be conducted in August. Staff is targeting the September 13<sup>th</sup> Village Board Meeting for approval of a technology firm.

Mayor Trilla called for questions. Trustee Davi asked if this was just an informational report. The Mayor responded "yes".

**4. DISCUSSION – Possible Addition of PPO Health Insurance**

Finance Director Dittman gave an overview on the Village's current health insurance. Willowbrook is a member of the Intergovernmental Personnel Benefit Cooperative (IPBC), which provides health and dental insurance



to a pool of municipal members; the Village is then part of a smaller sub-pool consisting of 5 neighboring communities (Burr Ridge, Clarendon Hills, Darien, Willowbrook & Woodridge). Our sub-pool has been an HMO only group since we joined IPBC, and our sub-pool bylaws dictate our cost sharing arrangement, thus a PPO option would not have been feasible in the past. In 2021, IPBC made changes to the overall IP BC member structure, and as a result the financial effects of a potential high claims history for future Village PPO members will not be as detrimental to us.

The Director continued and presented an analysis with charts providing a breakdown of costs to the Village and employees based on three deductible levels provided by IPBC as

the PPO plans each have member deductibles to be met: a \$500 individual/\$1,500 family deductible, a \$1,000 individual/\$2,000 family deductible (benchmark average of IPBC members), and a \$1,500 single/\$3,000 family deductible. The specifics and premiums of each are included in the packet as Exhibits A-1, A-2 & A-3.

The Village currently pays 100% of the single HMO health premium and 80% of dependent coverage, after deducting the single HMO premium (true subsidy is 86-90%). The attached preliminary analysis assumes that the HMO single deduction and employee contribution percentages would remain the same. The attached Exhibit B shows the current and proposed costs to the Village.

The discussion was then opened for questions.

Trustee Mistele asked about how many employees this affects, Director Dittman replied that we don't know how many employees would choose the PPO coverage, but that it would be open to all employees and all retirees on the Village health plan. Also, during annual open enrollment, the participant could switch plans. Trustee Mistele asked if we assumed 10 employees took the PPO the annual cost increase would be \$13,000? Director Dittman replied that would be the increase for 10 employees with SINGLE coverage (under the \$1,000 single/\$2,000 family deductible level), but the actual cost increase will vary depending on which tier of coverage they are.

A question was raised if anything was put out to Village retirees? Village Administrator Pabst replied that we are putting it out there to the Village Board first at this Special Meeting for discussion and direction for further analysis.

A trustee asked for the background on this issue. The question was raised as to why we haven't had a PPO in the past as some employees would prefer that form of insurance. Director Dittman provided information on the historical structure of IPBC and that we are in an HMO only sub-pool of IPBC as we have too few covered lives (about 40) to be a stand-alone member within IPBC. If we had offered PPO insurance in the past and had a few employees with large claims, in the next year when we had our renewal we may see our rates skyrocket as we would not have the blending effect of other members since our sub-pool was HMO only. In effect, we would be on our own with any PPO increases. IPBC's structural change in 2021 would

allow the Village to offer PPO coverage and maintain the pooling benefits of IPBC's extensive membership.

Trustee Neal recapped the information and a discussion ensued about employee contribution amounts. Administrator Pabst suggested that the next steps would be to survey the employees and other communities for employee contribution amounts and reevaluate the resulting costs.

Mayor Trilla agreed that more review was needed and that it was certainly worth more research.

Director Dittman noted that the earliest implementation could be January 1, 2022, mid-plan year, or at the normal plan year start, July 1, 2022.

## **5. DISCUSSION - Enterprise Leasing**

Police Chief Schaller presented information regarding the status of the Enterprise Leasing initiative.

At several Public Safety Committee meetings in early 2021, the committee directed staff to proceed with exploring the financial impact leasing would have on the overall police department vehicle budget. After exploring the equity leasing option offered by Enterprise Fleet Management, several benefits of leasing versus purchasing vehicles were discovered.

Chief Schaller explained that after the initial investigation, it was believed that leased provided the best solution. After researching further it was determined that the biggest stopping point for leasing versus purchase, was the return value of the squad cars, particularly Tahoes, at the end of the lease term.

The Chief also reported that the Enterprise representative was asked for an analysis of what others were doing and what they were historically getting for the return of their leased vehicles. As 2020 was an outlier year that skewed the results, Enterprise was asked to go back to 2018 for information. Enterprise could not produce that data. Additionally, Schaller reached out to the DuPage County dealership for historical information who reported that the current value of a 2012 Tahoe, with 100,000 miles, can be expected to garner \$10,500.00 at auction.

As of right now, Chief Schaller suggested going back to purchasing the vehicles that were allocated in the budget.

The Chief responded to a question that when the lease agreement was scaled back to 3-4 cars, Enterprise appeared to lose interest in the deal.

A discussion of the current age of the department vehicles and what has been budgeted in the coming years followed. Current status of the vehicles includes 3 over 100,000 miles and 4 at 92,000 plus. The budgeted replacement breakdown includes 3 in 2021/2022, 4 in 2022/2023, 2 in 2023/2024, 2 in 2024/2025 and 3 in 2025/2026.

At this point the Enterprise lease solution is out. The Chief has located a dealer, Curry Ford Co-op with 2020 Durangos and 5 Tahoes of which Willowbrook has earmarked two.

**6. REPORT - Monthly Disbursement Reports - June 2021**

Finance Director Dittman reviewed and highlighted the items below for the month of June.

- Vendor checks and payroll in June = \$1,127,159
- June payroll totals = \$339,406. The average payroll YTD is \$166,743, a 1.55% increase from last year.
- Total YTD average cash outlay for all Village funds - \$1,162,396
- Ave. daily outlay of cash for all Village funds - \$37,572; \$38,103 YTD.
- Ave. daily expenditures for the General Fund: \$24,423. Fiscal year to date average: \$23,171, a 12.5% decrease from last year.

**7. REPORT - Sales Tax, Home Rule Sales Tax, Business District Sales Tax, Income Tax, Utility Tax, Local Gas Tax, Places of Eating Tax, Hotel/Motel Tax, Fines, Red Light Fines, Building Permits, Water Revenues and Motor Fuel Tax**

Finance Director Dittman highlighted the major revenues for the month of June 2021 as follows:

- Sales tax receipts - \$421,287 up 17.03% from the prior year. The top 20 sales taxpayers as a group have increased 6.07% in the last 12 months compared to the prior year.
- 1% Home Rule Sales Tax receipts - \$222,867. There is no year over year comparison as this was implemented January 1, 2021
- Business District Sales Tax - \$56,124 up 48.74% from the prior year
- Income Tax receipts - \$127,220 up 137.16% compared to the prior year
- Utility tax receipts - \$56,516 down 2.51% from the prior year
- Local Gas Tax - \$19,467 up 31.41% from prior year
- Places of Eating Tax receipts - \$54,725 up 61.61% compared to the prior year
- Hotel/Motel Tax receipts - \$14,191 down 20.42% compared with the

prior year

- Fines - \$29,183 up 265.38% compared with the prior year
- Red Light Fines - Collected \$85,600 up 69.84% compared with the prior year
- Building Permit receipts - \$23,876 down 17.34% compared with the prior year
- Water Revenue receipts - \$271,356 up 5.45% compared with the prior year
- Motor Fuel Tax receipts \$27,904 up 39.14% compared with the prior year




In late 2019, a new and significant outbreak of Coronavirus Disease 2019 (COVID-19) emerged in China. The World Health Organization declared COVID-19 a Public Health Emergency of International Concern on January 30, 2020, and the United States Secretary of Health and Human Services declared that COVID-19 presented a public health emergency on January 27, 2020.

On March 9, 2020, Illinois Governor JB Pritzker declared all counties in the State of Illinois as a disaster area (Governor's Disaster Proclamation). Following the lead of Governor J. B. Pritzker, health agencies on both the State and Federal level, the DuPage County Board, on March 16, 2020, passed the DuPage County Disaster Proclamation. The Centers for Disease Control (CDC) and World Health Organization have declared the COVID- 19 a global pandemic.

On July 24, 2020, Illinois Governor JB Pritzker issued an additional Executive Order amending the criteria. On October 20, 2020, the Governor implemented additional restrictions limiting gatherings sizes and banning indoor bar and restaurant services beginning on October 23, 2020, for regions 7 and 8. On December 11, 2020, the Governor issued Executive Order 2020-74, further tightening restrictions on bars, restaurants, and social gatherings to help mitigate the spread of COVID-19. On November 20, 2020, the Governor implemented Tier 3 Resurgence Mitigation restrictions to combat the exponential growth of COVID-19 within the State. On January 18, 2021, the Governor revised the regulations for regions that have met certain criteria. Most recently, the Governor revised the restrictions and announced the entire state entered into the bridge phase as of May 14, 2021, and entered phase 5 as of June 11, 2021.

**STAFF RECOMMENDATION/PROPOSAL:**

It is the policy of the Village of Willowbrook that the corporate authorities will be prepared to address any emergencies and, therefore, pursuant to Section 5/11-1-6 of the Illinois Municipal Code, it is necessary and appropriate to establish standards for the determination of whether a state of emergency exists authorizing the Mayor to exercise extraordinary power and authority, by executive order, during the possible state of emergency, to ensure that the effects of COVID-19 are mitigated and minimized and that residents and visitors in the Village remain safe and secure.

If the ordinance is approved, it will allow for the following items allowable through the code of ordinances:

- a) All actions reasonably and expeditiously necessary to respond to the local state of emergency; and
- b) Approve previously appropriated expenditures of the Village for the purpose of continuing the operations of the Village; and
- c) In the event the local state of emergency extends beyond the current fiscal year and a new budget has not been approved, the Mayor shall be authorized to approve new spending by the Village during the existence of the local state of emergency;
- d) Canceling meetings of any board or commission to which the Mayor appoints members. Any such cancellation shall automatically extend such deadlines for required actions by such board of commission as is specified in the cancellation notice;
- e) Suspend licenses or permits for special events or any other licenses or permits issued by the Village which in the judgment of the Mayor could impact the public health or well-being of residents or visitors to the community;
- f) Authorize any purchase for which funds are available reasonably related to the local state of emergency; and
- g) Authorize to close Village facilities as is reasonably required to protect the health of the public and employees of the Village related to the local state of emergency.

This Extension of the Temporary Executive Power Ordinance will be in full effect until the next regular meeting of the Village Board of the Village of Willowbrook.

**ORDINANCE NO. 21-O-35**

**AN ORDINANCE EXTENDING TEMPORARY  
EXECUTIVE POWERS PURSUANT TO 65 ILCS 5/11-1-6**

**WHEREAS**, on March 23, 2020, the Governor of the State of Illinois issued Executive Order 2020-10 ordering all individuals, with certain exceptions, to shelter in place through April 7, 2020; and

**WHEREAS**, during the March 23, 2020 regular meeting of the Mayor and Board of Trustees of the Village of Willowbrook, the Village Board adopted and approved Ordinance 20-O-08, entitled “An Ordinance Establishing Temporary Executive Powers Pursuant to 65 ILCS 5/11-1-6”; and

**WHEREAS**, on March 23, 2020, Village Mayor, Frank A. Trilla, signed a “Proclamation Declaring An Emergency In The Village Of Willowbrook Due To The Coronavirus (COVID-19) Outbreak”; and

**WHEREAS**, on April 1, 2020, the Governor of the State of Illinois issued Executive Order 2020-18 extending for an additional thirty (30) days certain executive orders, including Executive Order 2020-10, ordering all individuals, with certain exceptions, to shelter in place through April 30, 2020; and

**WHEREAS**, effective May 1, 2020, Governor JB Pritzker signed Executive Order 2020-32 extending for another thirty (30) days prior Executive Orders continuing shelter-in-place orders until May 30, 2020; and

**WHEREAS**, during the April 27, 2020 regular meeting of the Mayor and Board of Trustees of the Village of Willowbrook, the Village Board adopted and approved Ordinance 20-O-13, entitled “An Ordinance Extending Temporary Executive Powers Pursuant to 65 ILCS 5/11-1-6”; and

**WHEREAS**, during the May 11, 2020 regular Village Board Meeting of the Mayor and Board of Trustees of the Village of Willowbrook, the Village Board adopted and approved Ordinance 20-O-17, entitled “An Ordinance Extending Temporary Executive Powers Pursuant to 65 ILCS 5/11-6”; and

**WHEREAS**, during the May 26, 2020 Village Board meeting of the Mayor and Board of Trustees, the Village Board adopted and approved Ordinance No. 20-O-19 extending temporary executive powers; and

**WHEREAS**, during the June 8, 2020 Village Board Meeting of the Mayor and Board of Trustees, the Village Board adopted and approved Ordinance No. 20-O-21 extending temporary executive powers; and

**WHEREAS**, during the June 22, 2020 Village Board Meeting of the Mayor and Board of Trustees, the Village Board adopted and the Mayor approved Ordinance No. 20-O-23 extending temporary executive powers; and

**WHEREAS**, on June 26, 2020, Governor JB Pritzker issued Executive Order 2020-44 (COVID-19 Executive Order No. 42) which extended prior Executive Orders related to the COVID-19 pandemic and again declared all counties in the State of Illinois disaster areas for an additional thirty (30) days; and

**WHEREAS**, on July 24, 2020, Governor JB Pritzker extended the Disaster Proclamations, previously issued, for an additional thirty (30) days; and

**WHEREAS**, on August 21, 2020, Governor JB Pritzker extended the disaster proclamation, previously issued, for an additional thirty (30) days; and

**WHEREAS**, on October 16, 2020, Governor JB Pritzker again extended the disaster proclamation for an additional thirty (30) days; and

**WHEREAS**, on November 13, 2020, Governor JB Pritzker again extended the disaster proclamation for an additional thirty (30) days; and

**WHEREAS**, on January 8, 2021, Governor JB Pritzker extended the disaster proclamation for an additional thirty (30) days and as further extended on February 5, 2021 by Executive Order 2021-4; and

**WHEREAS**, on March 5, 2021, Governor JB Pritzker extended the disaster proclamation for an additional thirty (30) days; and

**WHEREAS**, Governor JB Pritzker has again extended the disaster proclamation for an additional thirty (30) days through the first week of May, 2021; and

**WHEREAS**, on April 30, 2021, Governor JB Pritzker extended the disaster proclamation for an additional thirty (30) days; and

**WHEREAS**, on May 28, 2021, Governor JB Pritzker extended the disaster proclamation;

**WHEREAS**, on June 25, 2021, Governor JB Pritzker again extended the disaster proclamation; and

**WHEREAS**, the corporate authorities of the Village believe it is reasonable and necessary for the temporary executive powers afforded by Village Ordinances 20-O-08, 20-O-10, 20-O-13, 20-O-17, 20-O-19, 20-O-21, 20-O-23, 20-O-26, 20-O-29, 20-O-32, 20-O-36, 20-O-38, 20-O-44, 20-O-45, 20-O-48, 20-O-53, 20-O-55, 20-O-63, 21-O-01, 21-O-4, 21-O-7, 21-O-9, 21-O-11, 21-O-13, 21-O-16, 21-O-20, 21-O-22, 21-O-26, 21-O-30, 21-O-32, 21-O-34 and this ordinance be extended to the adjournment of the next regularly scheduled Village of Willowbrook Mayor and Board of Trustees' meeting.





#### ITEM HISTORY (PREVIOUS VILLAGE BOARD REVIEWS, ACTIONS RELATED TO THIS ITEM, OTHER PERTINENT HISTORY)

The Village of Willowbrook is currently utilizing Verizon for cellular communications, voice, and data. Village departments have experienced cellular communications interruptions, which has negatively impacted public safety and village operations.

#### ITEM COMMENTARY (BACKGROUND, DISCUSSION, KEY POINTS, RECOMMENDATIONS, ETC.)

Police staff began researching cellular networks and providers. Research indicated that ATT FirstNet was a dedicated public safety network that operates independently from ATT commercial cellular network.

FirstNet is the result of a public/private partnership between the First Responder Network Authority and AT&T. Based on recommendations from the 9/11 Commission Report, legislation was passed in 2012 to combine private sector resources, infrastructure, expertise and economies of scale with government resources—including Band 14. This highly desirable spectrum is dedicated to public safety by the federal government—to deploy and operate a first responder network. The network is designed to deliver priority and pre-emptive communications for first responders and other organizations involved in critical infrastructure and public health and safety.

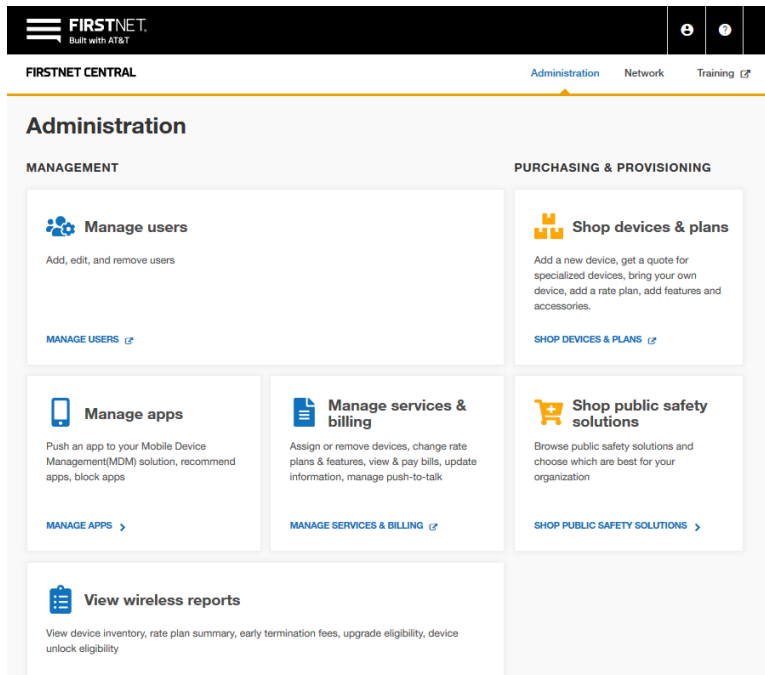

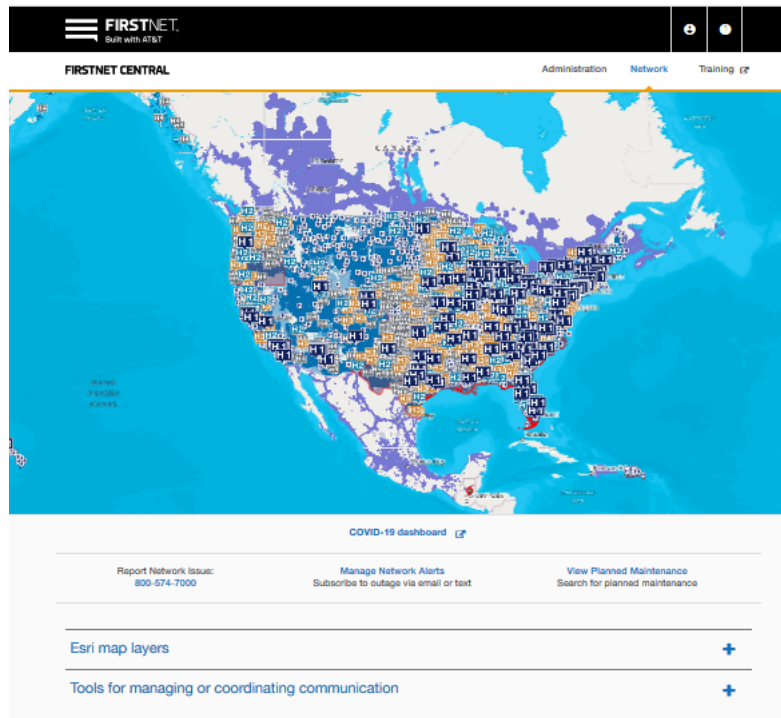



#### ITEM HISTORY (PREVIOUS VILLAGE BOARD REVIEWS, ACTIONS RELATED TO THIS ITEM, OTHER PERTINENT HISTORY)

Currently the Willowbrook Police Department is utilizing Fuji and Trek police bikes that are more than 10 years old and have reached their end-of-life cycle. The Police Department budgeted under line item #01-30-660-205 to purchase replacement bikes for FY 21/22.

#### ITEM COMMENTARY (BACKGROUND, DISCUSSION, KEY POINTS, RECOMMENDATIONS, ETC.)

Research was conducted and the Recon Commando battery powered police bike was the best fit for the department. Electric bikes have been around almost as long as traditional bicycles, but advances in motor and battery technologies in recent years have pushed electric bikes as the top choice in law enforcement. Traditional bicycles biggest downside is that they require a lot of energy to pedal and cannot go as fast as officers sometimes need to move. Officers utilizing an electric bike not only get to a scene faster – they also arrive stronger. The boost from the motor means an officer arrives at a scene less fatigued than he or she would be after powering a traditional bike at high speeds using just their legs, so they can use more energy for police work and less for pedaling. Total purchase price for two Recon Commando Power Bikes is \$6,424.00 which exceeds the budgeted funding by \$424.00. The remaining funding will be drawn from drug forfeiture funds.

Upon arrival, Officer Johnson relieved the individual, Robert Holliger, who was performing Cardiopulmonary Resuscitation (CPR) on the unresponsive victim. Officer Handzik deployed an Automated External Defibrillator (AED) and delivered a shock to the victim. After checking for responsiveness, a faint pulse was detected.

Officer Handzik nominated Mr. Holliger to receive the Willowbrook Police Department Citizen's Lifesaving Award as his quick actions during this medical emergency directly resulted in the preservation of the victim's life. The Willowbrook Police Department wishes to recognize and commend Mr. Holliger's life saving actions.

At the January 27, 2020 and the February 24, 2020 Municipal Service Committees, staff highlighted the findings of the Executive Plaza Drainage Master Plan and reviewed the most feasible design option which is to elevate the roadway and construct underground stormwater storage. This concept would provide a 100-year level of protection, while making the roadway passable to traffic. The projected project cost is estimated at +/- \$2 million plus the required engineering design cost.

At the May 26, 2020 Board of Trustees meeting, staff briefed the Board of Trustees on the basics of a Tax Increment Financing District (TIF). At that meeting, staff discussed opportunities to relieve the flooding in the Executive Drive area. The Village does not currently have a funding mechanism in place for the proposed improvements. The Village has worked with Kane, McKenna and Associates, Inc. to evaluate the use of a Special Service Area (SSA) option for a review of a \$2.5 million project. It was determined by the Committee that the SSA option would not be financially palatable to the property owners. At that time, staff was then directed to explore the possibility of creating a Tax Increment Financing (TIF) District for the area as an alternate funding option for the public improvements, environmental cleanup, and redevelopment costs within the area.

**ITEM COMMENTARY (BACKGROUND, DISCUSSION, RECOMMENDATIONS, ETC.)**

At the May 26, 2020 Board of Trustees Meeting, the Board approved the map located in Exhibit 1. After reviewing the map with Kane, McKenna and Associates and elected officials, staff believes there may be other alternatives to the existing map that will provide the greatest potential for redevelopment in Willowbrook.

Prior to making a decision, the Board should be aware of the steps required in the creation of a TIF District. The Village must identify an area that is economically stagnant, experiencing declining values, or has other factors wherein new development or redevelopment is desirable, but unlikely to occur at a reasonable pace if no public investment were to be provided.

The following concepts are included for tonight's discussion:

Exhibit 1 - The existing map that was approved by the Board of Trustees at the May 26, 2020 meeting.

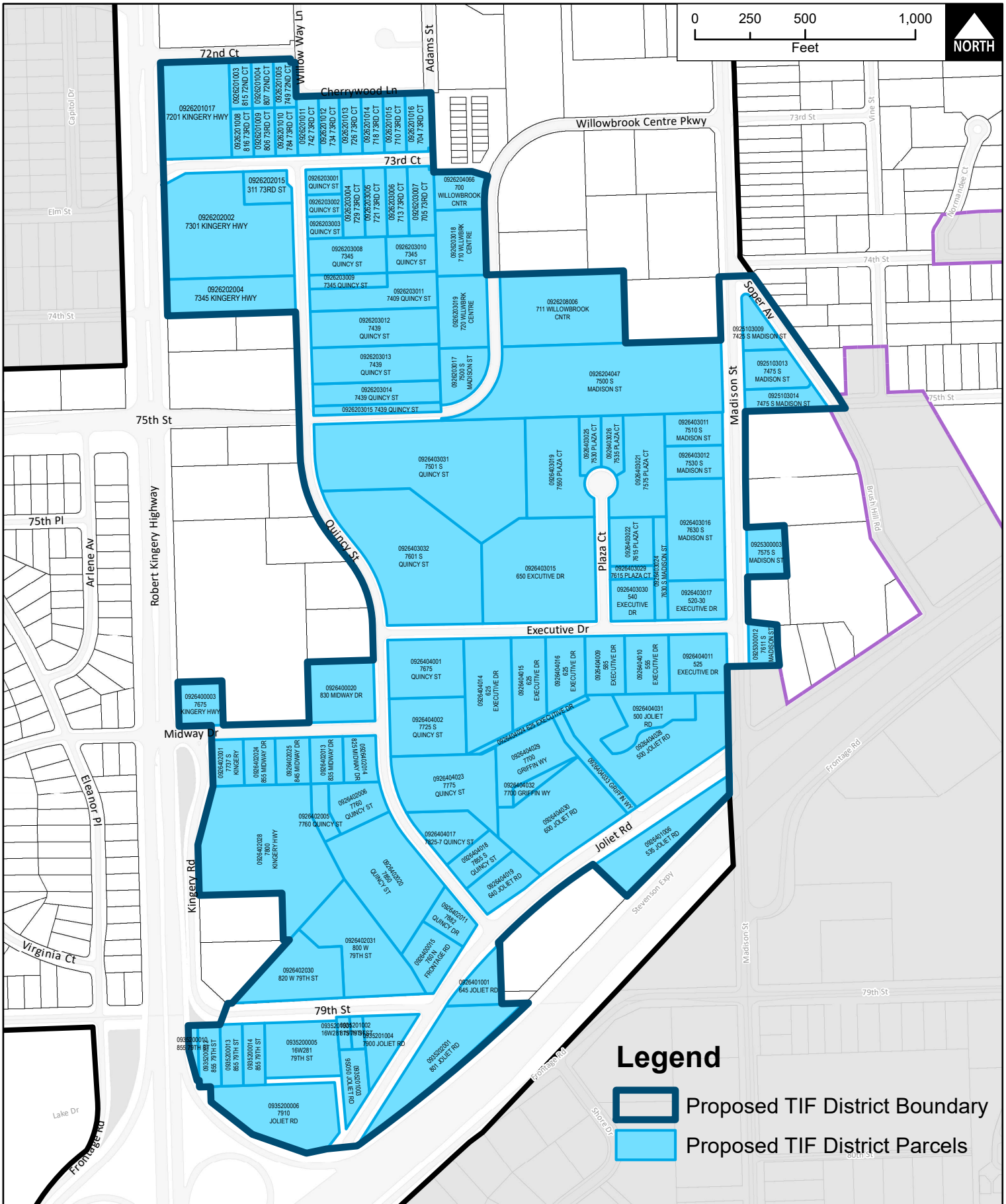

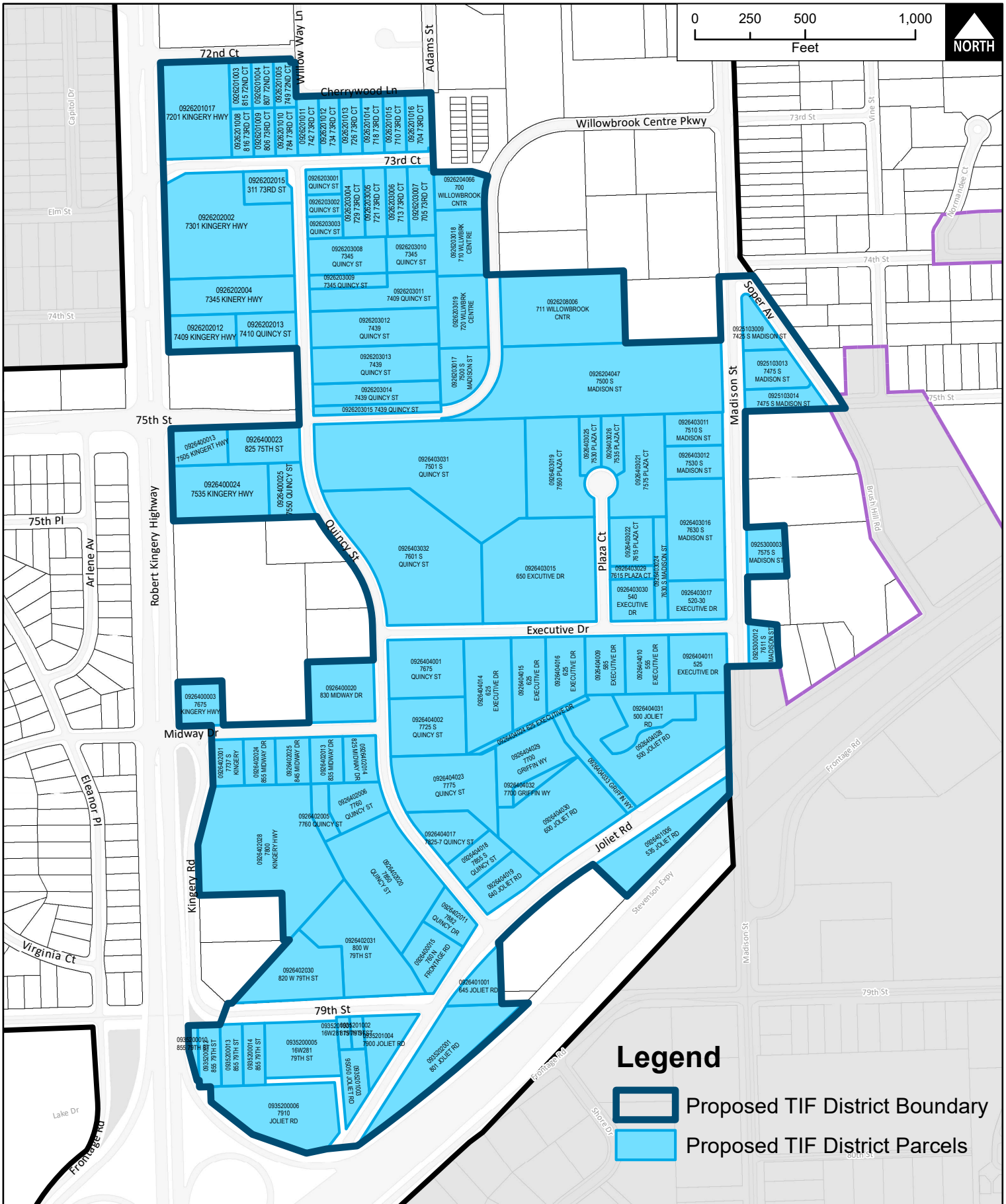
