This Labor Day, remember: Drive Sober or Get Pulled Over

"No excuses," says Willowbrook Police Department

Willowbrook, IL – As Labor Day and the unofficial end of summer near, **Willowbrook Police Department** is partnering with law enforcement throughout the state to stop impaired driving and help save lives.

While celebrations marking the last days of summer may look different this year than in times past, the potential remains for an increase in the number of impaired drivers on the roads. Impaired driving kills more than 10,000 people in the United States each year. Please plan ahead for a safe ride home before you leave the house. It truly is a matter of life or death.

The high-visibility "Drive Sober or Get Pulled Over" enforcement campaign runs from Aug. 20 through the early-morning hours of Sept. 7. During this period, motorists in ***Willowbrook, IL*** can expect to see stepped-up impaired driving patrols and seat-belt enforcement, particularly at night when seat-belt usage rates are at their lowest. Speeders and distracted drivers should also be aware.

If you're celebrating this Labor Day, remember to designate a sober driver and don't let friends or family members drive drunk. Even a small amount of alcohol can impair judgment and reaction times, making driving unsafe.

The Labor Day "Drive Sober or Get Pulled Over" campaign is made possible by federal highway safety funds administered by the Illinois Department of Transportation.

BACKGROUND

The DuPage County Children's Advocacy Center was founded in March of 1987. Its mission has been to provide a coordinated, multi-disciplinary approach to child sexual abuse investigations which recognizes the special needs of child victims while demanding accountability for the crime of sexual abuse.

In 1999, State's Attorney Joseph E. Birkett, the Chairman of the Children's Center Advisory Board, expanded the mission of the Center to provide the same coordinated approach to cases involving serious physical abuse of children.

In 2001, State's Attorney Birkett expanded the mission to include interviewing children who have witnessed domestic violence or violent crimes at the request of any police department or prosecutor.

The DuPage County Children's Advocacy Center is a specialized unit of the DuPage County State's Attorney's Office. Consisting of a Director, a Deputy Chief of Investigations, criminal investigators, child protective investigators on special assignment from DCFS, case managers and a division assistant. The Children's Center investigates and processes all cases of child sexual and severe physical abuse in the County and works with children who witness violent crimes. The Children's Center relies on funding from federal, state, county, local and private sources to provide services.

THE DUPAGE COUNTY CHILDREN'S ADVOCACY CENTER ANNUAL REPORT 2020

The DuPage County Children's Advocacy Center is a specialized unit of the DuPage County State's Attorneys Office that provides a coordinated multidisciplinary approach to child sexual abuse or assault and severe physical abuse occurring in DuPage County. The DuPage County Children's Center will also interview children who have witnessed violent crime.

The goals of the DuPage County Children's Center are to:

- A. Insure the safety and minimize the trauma to victims of child abuse and their families as they turn to the justice system for protection.
- B. Provide a coordinated multidisciplinary approach to child abuse investigations and intervention.
- C. To seek justice not merely to convict.
- D. Insure victims receive support and advocacy throughout the judicial process.
- E. Insure that victims and their families receive appropriate treatment and social services to assist them in their healing.
- F. To provide professional training and community education.

The Director, Patrick Dempsey, is responsible for the overall operations, coordination and administration of the Center. Staffing consists of nine Senior Criminal Investigators (all assigned from the Investigations Unit of the Office of the State's Attorney), three full-time case managers, child protection investigators (assigned by the Illinois Department of Child and Family Services) and a division assistant. Assistant State's Attorneys work closely with Center staff during the investigative process and make the determination as to whether and what charges will be filed.

The case managers are responsible for coordinating aftercare services to victims and their families. The case managers maintain supportive therapeutic contact with families from case initiation throughout the prosecution of the case. Very often families feel isolated from the process and have many questions about the investigation and follow-up. The Center acts as a clearinghouse, gathering and compiling all the information the family might need. Without the case manager services, families feel uninvolved and simply drop out of sight, failing to cooperate with the judicial process and further protect the child. Services provided include court advocacy, medical advocacy, referrals to community agencies for emergency and support services. The case managers refer non-offending parents to outside agencies that provide monthly support groups.

The Children's Center has an Advisory Board which is chaired by State's Attorney Robert B. Berlin and includes law enforcement and child welfare specialists as well as county officials.

Center Staff

Supervisory staff is minimally required to possess a BA or BS and several years of supervisory experience. Criminal investigators are required to be certified police officers who have attended and successfully completed the requirements of the Illinois Law Enforcement Standards Board. Previous investigative experience is preferred. Case managers are required to possess a BA or BS or equivalent work experience. The State of Illinois determines the minimum qualification for child protection investigators.

Director – Patrick Dempsey

The Director is responsible for planning, organizing, directing and reviewing the investigation and follow up services of child sexual abuse and severe physical abuse cases as well as educating community professionals in child abuse awareness.

Criminal Investigators - The criminal investigators investigate allegations of child sexual and severe physical abuse. The investigators conduct victim sensitive forensic interviews and are responsible to provide written reports on all interviews.

Case Management- The case manager provides crisis and supportive intervention during the investigative process, medical and legal advocacy, assessment, referral and linkage to follow-up treatment services and court preparation when needed.

Stephanie Mogensen has a bachelor's degree in Psychology. Ms. Mogensen has over fifteen years of experience in victim/witness advocacy.

Maria Rivera has over fifteen years of experience in victim/witness advocacy and is bi-lingual (Spanish).

Robert Gonzalez has completed most of the requirements for a bachelor's degree in criminal justice. He has over fifteen years of experience working with victims in the States Attorney's Office and is bi-lingual (Spanish).

Mary Olmstead is the Center's Administrative Assistant. The Administrative Assistant performs all clerical duties for the Children's Center. Ms. Olmstead has a combined experience of over ten years with the State's Attorney's Office. She started with the Children's Center in 2014.

2020 Statistics

In 2020, the Children's Center received 414 reports with a total of 438 victims. The CAC opened **284 case investigations** with investigators conducting 295 child interviews (victims, siblings and child witnesses) and 389 interviews of adults and ages unknown.

SIGNIFICANT CASES HANDLED BY THE CENTER IN 2020

A fourteen old girl, a resident of Ohio, came with her family to visit relatives in Darien for a weekend. While at the Darien residence, several of the children and their 45 year old uncle were playing a hide and seek game. While the victim and her uncle were alone in the garage, he fondled her breasts on two occasions. The girl disclosed the abuse several months later after returning home to Ohio. The victim's mother contacted the uncle and confronted him about his actions. He apologized for what he did and hoped that the victim was not emotionally affected by what he had done.

The subject is employed as an engineer but also has a position as a minister in a local church.

Charges were approved for two counts of Aggravated Criminal Sexual Abuse. He turned himself in and was able to post bond. The court case is pending.

The Madison, Wisconsin Police Department and the Glendale Heights Police Department forwarded the DuPage County Children's Center an investigation in regards to the sexual assault of nine year old female victim by the nine year old female victim's grandmother's boyfriend. The sexual assault occurred in Madison, Wisconsin. A Forensic interview was conducted with the nine year old female victim at the DuPage County Children's Center. The victim was asked to name the body parts on an anatomical drawing of a female child and an adult male. The victim stated the grandmother's boyfriend touched her vagina with his hand over her clothes, The victim stated the grandmother's boyfriend grabbed her hand and made her touch his penis under the clothes, The Dane County, Wisconsin District Attorney's Office charged the suspect with First Degree Sexual Assault/Sexual Contact with a person under the age of thirteen.

This case was opened 5-01-20 after 16 year old female victim disclosed that she was being sexually molested by her 30 year old brother in-law. Victim sensitive interview was conducted on victim in which she disclosed that her brother in-law had been sexually molesting her since she was 12 years old and the abuse had

stopped when she was 15 years old. Victim disclosed that her brother in-law would fondle her breast and vagina both inside and outside of her clothing with his hands and fingers. She disclosed he would digitally penetrate her vagina and also perform oral sex on her. She added he would also fondle her buttocks and rub his penis on both her vagina and buttocks, Victim further stated she was made to masturbate her brother in-law's penis and perform oral sex on him. The brother in-law was subsequently interviewed and he admitted to having a sexual relationship. He said the sexual relationship started when the victim was 12 years old and stopped when she was 13 years old. He admitted to touching her vagina with both his hands and fingers, rubbing his penis against her vagina, making sure he did not penetrate her vagina. He further admitted having victim perform oral sex on him and him performing oral sex on her until he ejaculated. He was subsequently arrested on 3 counts of Predatory Criminal Sexual Assault of a Child.

On 09/24/20 assigned a sexual assault investigation with a 16 year old victim and a 32 year old offender. The two met in a park and the offender grabbed and digitally penetrated the victim's vagina. The offender had also produced a handgun from a bag days prior to this incident and showed it to the victim. The offender was located in front of the victim's residence in Carol Stream and arrested. We interviewed the offender at the Carol Stream Police Department. We executed a search warrant at the offender's residence and he was charged on multiple charges including unauthorized recording of the victim.

Victim was 10-year-old female who was at the center after disclosing to her mother that the Subject had touched her private parts. Victim said when she was in second grade. Subject began touching her on the arms and legs under her clothing. Victim stated Subject touched her private part (vagina) with his hand on the inside and outside of her vagina. Victim advised that happened 2- 3 times per week. Victim said during the summer of 2018 Subject would "put his private part (penis) in my private part (vagina)." Victim stated this happened 3-4 times per week until approximately December 2018. I interviewed Subject in reference the allegation and initially he denied knowing the victim and her family in this case. Subject denied touching Victim for sexual purposes but admitted to accidentally touching her vagina when he picked her up to spin her around. Charges were denied due to insufficient evidence.

Case involved two adoptive brothers aged 13 and 16. The 13-year-old told his mother that the 16 year old step-brother would sexually assault him. I interviewed the 13-year-old who said that his step-brother had put his penis between his buttock cheeks and rubbed it there. The 13-year-old said that he could feel warm liquid on his cheeks. The 13-year-old said that this happened approximately 100 times over the last two years. I interviewed the 16-year-old at Aunt Martha's Health and Wellness Center in Chicago as he was removed from the home. The 16-year-old admitted to performing the above acts on his brother and ejaculating on his buttocks. The 16-year-old said that this had occurred about 30 times. When asked if he would do it again if he was back home, the 16-year-old paused for a while and then said no. The 16-year-old was charged in juvenile court.

GOALS AND OBJECTIVES 2021

1. Continued training for investigators and case managers.
 - Investigators focus on forensic interviewing and physical abuse investigations.
 - All investigators will be certified through the Children's Advocacy Centers of Illinois for peer review.
2. Continue presentations on protocol, interviewing victims and parent education to schools, social organizations and police agencies.
