We are awaiting a response from him if he wants to continue or withdraw from the background/application process with our department. If he decides to pass, we will then move onto candidate number three.

Chief Kaspar discussed updating the testing process.

Chief Kaspar advised that the Committee has the Village Board approval to hire (1) lateral and (1) BOPC candidate.
