1. CALL TO ORDER

The meeting was called to order at 5:30 p.m. by Mayor Frank Trilla.

2. ROLL CALL

Those physically present at roll call were Mayor Frank Trilla, Village Clerk Gretchen Boerwinkle, Trustees Mark Astrella, Sue Berglund, Umberto Davi, Michael Mistele, Gayle Neal, Gregory Ruffolo, Village Attorney Michael Durkin, Village Administrator Sean Halloran, Assistant Village Administrator Alex Arteaga, Chief Financial Officer Lora Flori, Director of Community Development Michael Krol, Director of Parks and Recreation Dustin Kleefisch, Director of Public Works Rick Valent, Chief Lauren Kaspar, and Deputy Clerk Christine Mardegan.

Mayor Trilla asked the Board if there were any items to be removed from the Omnibus Vote Agenda.

6. ITEMS FOR DISCUSSION:

a. POLICE DEPARTMENT COMMUNITY ENGAGEMENT

Chief Kaspar updated the Board on the department's current goals and objectives for the fiscal year in terms of community engagement. This effort has been a primary goal for the police, particularly since the COVID lockdowns in 2020/2021 and the community ties that were lost then.

In 2023 the department began by establishing a COPS unit to create a community-oriented policing unit. Officers have attended homeowner's association meetings, fulfilling requests for various presentations, including crime trends, how to keep people and residents safe and other prevalent crime issues. Officers have participated in about 8 per year.

In 2024, the program was expanded to include partnerships with some of the area youth programs, such as those presented by the Village's Parks and Recreation department and reaching out to the Indian Prairie Library for a reading program during the school year. That program recently concluded a couple of weeks ago with a pizza party at the PD for the participants.

In 2025, a Citizens Police Academy was initiated. The first class graduated in May with seven attendees participating in six weeks of programming which included traffic stop information, crime scene investigation, and more. The program received great feedback.

In the 2025/2026 fiscal year, a safety open house partnership with the Tri-State Fire District will be reestablished with presentations from local utilities, road safety from the Tollway Authority, and input from other interested vendors. Tri-State will be offering a car seat installation demonstration with trained personnel. The date is currently set to cohost with Tri-State at the Willowbrook Police department on September 13<sup>th</sup>.

Another initiative the department would like to establish is the neighborhood roll call, where officers conduct a roll call briefing at a specific time, on a specific street, in a specific neighborhood. The roll call would be advertised through social media, the Village website and via neighborhood signage. Topics would include the COPS program, community crime prevention programs, the Citizens Police Academy as well as the social worker program and the partnership with Tri-State. Neighborhood roll call provides an opportunity for positive interaction and for residents to ask questions and talk to law enforcement one-on-one with the same officers who would be responding to an emergency in their neighborhood.

The roll call program will take place during the summer months in the evenings after most residents have returned home. Sergeant Inez Benson will be one of the primary officers leading the program.

The Board had several questions following the Chief's presentation.

In response to a question regarding working with Tri-State on car seat installation rather than training our own officers, Chief Kaspar indicated that an additional liability is involved in offering the installation. Tri-State already has the trained staff and is willing to work in partnership with Willowbrook.

Providing additional information on the proposed open house, Chief Kaspar indicated it would be held from 11 a.m. to 2 p.m. and be set up in the Municipal Campus parking lot. In the event of weather issues, alternate setups may be at the CRC or in the sally port at the PD.

Trustee Neal was most concerned with the roll call proposal, particularly that it might send the wrong message. She wanted to know what other communities were offering this type of community engagement. Chief Kaspar indicated that Elmhurst is one of the pilot programs. At last year's DMMC Innovation Celebration, Elmhurst received an award for this roll call program idea.

Sergeant Benson had also broached the idea of a roll call program previously with the Chief along with the Coffee With a Cop program as well as a roll call program. She noted that these have long been used in Chicago for community outreach purposes, allowing residents to ask questions and talk about their concerns. Willowbrook started with Coffee With a Cop, but that program did not get much reaction or participation.

Trustee Neal still had concerns regarding the perception of an on-street roll call. With the example of Elmhurst as the closest community, and Chicago's participation in the exercise, she felt that Willowbrook was a very different type of environment. Her primary concerns were sending the wrong message to residents, causing residents to panic or be frightened by the police presence in their neighborhood, and how widespread the program would be.

Chief Kaspar responded to Trustee Neal by providing additional details on how the program would be set up, what types of notifications would be provided by the Village and the Department to alert neighborhoods to the event, and what the focus of the roll calls would be. She concluded by indicating that the idea was beneficial to provide residents with a way to get to know the police outside of an emergency, to be able to

respond to residents' questions and concerns in a relaxed atmosphere, and to provide residents with information on police initiatives.

Several other trustees spoke in favor of the program citing reasons such as an opportunity to engage with the community, to assist in encouraging members of the community to "see something / say something", providing additional services to the community, and engaging more members of the community.

b. WINTER WONDERLAND AT WILLOW POND

Director Kleefisch introduced the topic of a Winter Wonderland event. This event would bring a thematic holiday experience to Willow Pond for the residents that would help bolster local tourism and vitality in the area and create a winter destination to enhance our community.

Staff reached out to three providers of this type of activity. Only one, Holiday Outdoor Décor, being presented tonight, offered both a lease and a purchase option. Staff is seeking input on the direction the Board would like to move forward.

The various illuminated holiday displays would be distributed through the park, allowing for a leisurely walk through the park, and special experiences including photo ops and a unique recreational opportunity. Director Kleefisch presented a PowerPoint slideshow with examples of the displays available, and a sample Willow Pond Park map with suggested locations to distribute throughout the park and along the walking path.

With the leasing option, Holiday Outdoor Décor would deliver and set everything up just prior to the event. Additionally, at the conclusion of the extended event, they would break down the displays and store them until the next season. They would also handle any repairs or maintenance. In subsequent years, if the Village finds that one or more of the displays are not as successful or popular as the others, there would also be an opportunity to remove that item and/or select an alternate display.

In coming years, staff would like to see the set up moved to Borse Memorial Park after the renovation is complete, to become an extension or enhancement to the Light Up the Night event.

Staff is seeking direction on two items, one, to move forward with this budgeted item, and two, concur with the staff recommendation to utilize the leasing option offered by the vendor.

The Board consensus was to move forward with the event and utilize the leasing option offered by Holiday Outdoor Décor although Trustee

Berglund was opposed to the idea and felt the combined cost of conducting both the Light Up the Night and Winter Wonderland events was too high.

In conclusion, the Mayor expressed strong support for both events. He felt this was a natural progression of the holiday events held during his tenure as mayor which was previously represented by a Christmas tree at 63<sup>rd</sup> and Route 83, surrounded by crime scene tape as a deterrent to any type of vandalism. He feels that now we can have affordable decorations and events worthy of the Village and of benefit to the entire Village.

### **PURPOSE AND ACTION REQUESTED**

Staff is presenting proposals for the demolition and site restoration of the residential properties located at 610 and 618 Plainfield Road and providing information on proposed uses and future development of these properties.

### **BACKGROUND/SUMMARY**

The Village acquired the properties at 610 and 618 Plainfield Road to support potential future uses, including expanded recreational opportunities, economic development, or stormwater improvements. While a final use has not yet been determined, as a first step, the proposed demolition will prepare the site for future project consideration.

The scope of the demolition and site restoration work will include:

- Utility disconnection (gas meter and service line removal)
- Tree and stump removal
- Freon removal from HVAC systems
- Installation, maintenance, and removal of construction fencing
- Demolition of the house, driveway, and detached garage
- Backfilling of foundations
- Full site restoration upon project completion



As a first step, staff sought estimates on the various tasks required for the demolition project. The estimated costs, broken down by property and vendor, are as follows:

Once the site is cleared, staff will return to the Board over the course of the next few months to gather input on proposed uses and to present various ideas and options for site development.

## FINANCIAL IMPACT

Total project cost for the demolition and site restoration is expected to not exceed \$184,356.50. These costs will be expensed from the Opportunity Reserve Fund.

## RECOMMENDED ACTION:

Staff is seeking input from the Board on the proposed demolition and site restoration of the residential properties located at 610 and 618 Plainfield Road and discussion of proposed uses and development.

### **PURPOSE AND ACTION REQUESTED**

Discussion of adopting a local ordinance to enforce the criminal misdemeanors of prostitution, soliciting for a prostitute, and keeping a place of prostitution within the Village of Willowbrook.

### **BACKGROUND/SUMMARY**

In December of 2023 the Village Board adopted an ordinance establishing an Administrative Adjudication system to aid in creating an effective and efficient process for dealing with municipal code compliance and resolution. Additionally, all fines and costs assessed would be retained by the Village, not disproportionately distributed to the County as it currently stands.

Currently there are several criminal misdemeanors listed under Title 5 Police Regulations, Chapter 3 of the Village Code of Ordinances, which allows for enforcement at the local level. These misdemeanors include Battery, Assault, Retail Theft, Disorderly Conduct, and several other public nuisance misdemeanors. When cited under local ordinance, these public nuisance misdemeanors are placed into the Village's administrative adjudication process.

Through our recent enforcement activities, the following three public misdemeanors have been identified as beneficial to add to Title 5, Chapter 3:

#### **720 ILCS 5 Sec. 11-14. Prostitution**

(a) Any person who knowingly performs, offers or agrees to perform any act of sexual penetration as defined in Section 11-0.1 of this Code for anything of value, or any touching or fondling of the sex organs of one person by another person, for anything of value, for the purpose of sexual arousal or gratification commits an act of prostitution.

#### **720 ILCS 5 Sec. 11-15: Soliciting for a prostitute**

(a) Any person who performs any of the following acts commits soliciting for a prostitute:

- (1) Solicits another for the purpose of prostitution; or
- (2) Arranges or offers to arrange a meeting of persons for the purpose of prostitution; or



(3) Directs another to a place knowing such direction is for the purpose of prostitution.

## **720 ILCS 5 Sec. 11 17: Keeping a Place of Prostitution**

(a) Any person who has or exercises control over the use of any place which could offer seclusion or shelter for the practice of prostitution who performs any of the following acts keeps a place of prostitution:

(1) Knowingly grants or permits the use of such place for the purpose of prostitution; or

(2) Grants or permits the use of such place under circumstances from which he could reasonably know that the place is used or is to be used for purposes of prostitution; or

(3) Permits the continued use of a place after becoming aware of facts or circumstances from which he should reasonably know that the place is being used for purposes of prostitution.

Adding these three misdemeanors to the Village's municipal code will give officers another level of enforcement and aid in the efficient resolution of these criminal acts.

**ORDINANCE NO. 25-O-\_\_\_\_\_**

**AN ORDINANCE OF THE VILLAGE OF WILLOWBROOK AMENDING CHAPTER 3  
ENTITLED "MISDEMEANORS" OF TITLE 5 ENTITLED "POLICE REGULATIONS"  
OF THE VILLAGE CODE OF ORDINANCES OF THE  
VILLAGE OF WILLOWBROOK**

---

**WHEREAS**, the Village of Willowbrook, DuPage County, Illinois, is a home rule municipality pursuant to Article VII, Section 6, of the Constitution of the State of Illinois; and

**WHEREAS**, the Section 1-2-1 of the Illinois Municipal Code (65 ILCS 5/1-2-1), provides that the corporate authorities of each municipality may pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities, with such fines or penalties as may be deemed proper; and

**WHEREAS**, Section 1-1-10 of the Illinois Municipal Code (65 ILCS 5/1-1-10) empowers the corporate authorities of the municipality to exercise all powers granted to it expressly, by necessity, by the Illinois Municipal Code, by Illinois statute, or by the Illinois Constitution; and

**WHEREAS**, Section 11-60-2 of the Illinois Municipal Code (65 ILCS 5/11-60-2) empowers the corporate authorities of each municipality to define, prevent and abate nuisances; and

**WHEREAS**, pursuant to the Village's home rule powers and applicable authority, the corporate authorities of the Village of Willowbrook have determined that it is in the best interest of the Village of Willowbrook to amend Title 5, Chapter 3, to add the public nuisance misdemeanors of prostitution; solicitation of a prostitute; and keeping a place of prostitution to the list of criminal misdemeanors which may be prosecuted locally, within the Village.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Willowbrook, DuPage County, Illinois, as follows:

**SECTION 1:** The foregoing recitals are found to be true and correct and incorporated as if

fully set forth herein.

**SECTION 2:** That Chapter 3 entitled “Misdemeanors” of Title 5 entitled “Police Regulations” of the Municipal Code of the Village of Willowbrook, as amended, is hereby further amended by adding thereto the following section:

“5-3-31: Prostitution

- (A) It shall be unlawful for any person who knowingly performs, offers or agrees to perform a lewd act, including any act of sexual penetration, as defined in Section 11-0.1 of the Illinois Criminal Code (720 ILCS 5/11-0.1), for anything of value, or any touching or fondling of the sex organs of one person by another person, for anything of value, for the purpose of sexual arousal or gratification.
- (B) It shall be an affirmative defense to a charge under this Section that the accused engaged in or performed prostitution as a result of being a victim of involuntary servitude or trafficking in persons, as defined in Section 10-9 of the Illinois Criminal Code (720 ILCS 5/10-9).

5-3-32: Soliciting a Prostitute

- (A) It shall be unlawful for any person who performs any of the following acts:
  - 1. Solicits another person for the purpose of prostitution; or
  - 2. Arranges or offers to arrange meeting of persons for the purpose of prostitution; or
  - 3. Directs another to a place knowing such directive is for the purpose of prostitution.

5-3-33: Keeping a Place of Prostitution

- (A) It shall be unlawful for any person who has or exercises the use over any place which could offer seclusion or shelter for the purpose of prostitution, and performs any of the following acts:
  - 1. Knowingly grants or permits the use of such place for the purpose of prostitution; or
  - 2. Grants or permits the use of such place under circumstances from which he or she could reasonably know that the place is used or is to be used for purposes of prostitution; or
  - 3. Permits the continued use of a place after becoming aware of facts or

circumstances which he or she should reasonably know that the place is being used for the purpose of prostitution.”

**SECTION 3:** Any ordinance or portion of any ordinance in conflict with any provisions of this ordinance is hereby repealed, solely to the extent of such conflict.

**SECTION 4:** This ordinance shall be in full force and effect from, upon and after its passage and approval and publication in the manner provided by law.






a. Total Dispatched Calls for the second quarter of calendar years 2021 through 2025


b. Traffic Enforcement Summary the second quarter of calendar years 2021 through 2025




c. Traffic Accident Summary for the second quarter of calendar years 2021 through 2025






e. A heat map overview for calls requiring written reports during the second quarter of calendar year 2025



DISCUSSION REGARDING A PARTNERSHIP WITH THE VILLAGE OF WESTERN SPRINGS TO OFFER TRIPS FROM WILLOWBROOK'S ACTIVE ADULT PROGRAM

#### **PURPOSE AND ACTION REQUESTED**

The purpose of this item is to seek input from the Board of Trustees on forming a partnership with the Village of Western Springs to offer Village of Willowbrook Active Adult trips.

#### **BACKGROUND/SUMMARY**

The staff of the Village of Western Springs and Village of Willowbrook began conversations about partnering on Active Adult trips in March 2024. Unfortunately, due to several unforeseen circumstances and a leadership change in Western Springs, progress on the partnership was significantly delayed. The Village of Western Springs has maintained interest in the program and has resumed the conversation about partnering on travel trips. Presently, the Village of Western Springs operates a Senior Center that offers various programs and activities, however, they currently do not offer off-site trips.

The agreement with the Village of Western Springs is to partner on travel trips and will include "The Scoop" being advertised at their Senior Center and on their website. In return, Willowbrook will offer the residents of Western Springs the resident rate on the Active Adult travel trips. The initial agreement will run for one calendar year, from August 1<sup>st</sup>, 2025, to August 1<sup>st</sup>, 2026 after which the parties will meet again to determine whether to continue or dissolve the partnership.

This partnership agreement is similar to the other Active Adult partnership agreements that are currently in place with the Burr Ridge Park District, the Darien Park District, and the Village of Hinsdale. The collaboration between Willowbrook and Western Springs will help better serve the residents and help both the Senior Center and the Active Adult program from a logistical and financial standpoint.
