CALL TO ORDER

Meeting called to order at 5:30pm.

1. REVIEW OCTOBER 8TH, 2018 PUBLIC SAFETY COMMITTEE MEETING MINUTES.
The Committee approved the October 8th, 2018 meeting minutes.
2. REVIEW WEEKLY PRESS RELEASES – INFORMATION.
The Committee reviewed the Weekly Press Releases. Chief Schaller discussed an arrest that occurred in the parking lot of the police department.

6. DISCUSSION ITEMS

- Vehicles

Chief Schaller discussed the purchase of a police vehicle. The Chief advised that per Fleet Sales at Currie Ford, who has the fleet contract for Suburban Purchasing Co-op, that the Ford 2018 Police Interceptor has been over sold by 2000 units.

New 2020 production for the Ford will not begin until June 2019. Ford has included a price increase. A price comparison of the Ford SUV and the Chevrolet Tahoe has determined a cost difference of \$250.00 U.S.C. between the vehicles, with the Chevrolet Tahoe costing less than the Ford SUV.

The previous Chevrolet Tahoe K-9 vehicle is still in service. This vehicle has 90,000 miles on the odometer and has no mechanical issues.

The Chevrolet Tahoe is currently available, without waiting, until June 2019. The production is similar to that of the Ford SUV.

Chairperson Neal and Trustee Davi agreed to move ahead with the purchase of the Chevrolet Tahoe Police Pursuit Vehicle.

Chief Schaller discussed the importance of starting a Police Department Twitter page as another tool for providing information to Willowbrook Residents.

Chief Schaller advised the Committee that he will be looking into social media archive software for discussion at the upcoming budget workshops.

- Canine
Chief Schaller discussed the passing of K-9 Artos and that the necropsy results have not yet come back from the U of I.
