Willowbrook Police Department announces 'Click It or Ticket' campaign numbers

Willowbrook, IL — The Willowbrook Police Department today announced it issued **24** citations during the recent Memorial Day "Click It or Ticket" enforcement period.

"Through the Memorial Day enforcement campaign, we helped make Illinois roads safer and spread the word that seat belts save lives," said Chief Robert Schaller

While Illinois' 2020 seat belt compliance rate was 94.6%, unbelted occupants still account for over half of those killed in traffic crashes. The "Click It or Ticket" campaign aims to change the behavior of the millions of people who do not buckle up. Thousands of lives could be saved each year if every vehicle occupant was properly restrained when traveling.

During the enforcement period, the Willowbrook Police Department wrote **6** citations for seat belt violations.

The Illinois "Click It or Ticket" campaign is administered by the Illinois Department of Transportation with federal highway safety funds.

Willowbrook Police Department begins Fourth of July safety campaign to encourage safe and sober driving

Willowbrook, IL – The Willowbrook Police Department announced plans for stepped-up July Fourth traffic enforcement with a focus on impaired and unbuckled drivers. The safety campaign will run from June 17 through the early-morning hours of July 6 to encompass three summer weekends leading up to and after Independence Day.

We are asking all of our residents and visitors to celebrate Independence Day safely. It is simple: If you are driving, do not drink, use marijuana or other drugs. Our officers will be working around the clock to keep impaired drivers off the road and enforce all other traffic laws.

The Willowbrook Police Department will join the Illinois State Police and more than 200 local police and sheriff's departments for the increased statewide enforcement effort.

Use these tips to help ensure a happy and safe holiday:

- Designate a sober driver and give them your keys before you go out.
- Don't let friends or family members drive under the influence.
- If you are drunk or impaired by marijuana or other drugs, call a taxi, take mass transit, use your favorite ride-sharing service, or call a sober friend or family member to get you home safely.
- Promptly report drunk drivers to law enforcement by pulling over and dialing 911.
- Make sure everyone in your vehicle wears their seat belt. It's not only the law, but also your best defense against an impaired driver.

The "Drive Sober or Get Pulled Over" and "Click It or Ticket" programs are made possible by federal traffic safety funds administered by the Illinois Department of Transportation. The enforcement period runs concurrently with a media campaign reminding motorists that impaired driving has "Life or Death" consequences. Visit LifeOrDeathIllinois.com for more information.
