



# DOWNERS GROVE REGIONAL PEER JURY PROGRAM



## Participant Liability Waiver and Hold Harmless Agreement

Please read this form carefully. It affects your ability to recover for injuries and damages against the municipalities participating in the Downers Grove Regional Peer Jury Program, specifically: the Village of Downers Grove, City of Darien, Village of Willowbrook, Village of Hinsdale, Village of Clarendon Hills, the Village of Oakbrook and the Village Burr Ridge (collectively referred to as "Municipalities"). Be aware that by registering for and participation in this program, or by registering your minor child/ward for participation in this program, you will be waving your rights and/or the rights of your minor child/ward to all claims for injuries you and your minor child/ward might sustain arising out of this program and you will be required to indemnify, hold harmless and defend the Municipalities for any claims arising out of participation in the Downers Grove Regional Peer Jury Program. Persons registering for and participating in this Peer Jury Program are referred to in this document as "Participant(s)".

**Participant Waiver:** By signing this document, the minor participant states that he/she understands there are certain risks of physical injury associated with the program. The participant assumes the full risk for any and all losses, which may include bodily injury, and/or damage to property as a result of participating in any and all activities associated with this program and releases the Municipalities from any claims of violations of confidentiality in regards to adjudication of the case.

**Parent/Guardian Waiver and Release.** By signing this document, the below named parent or legal guardian of a participant in the program waives any right of recovery against the Municipalities on behalf of yourself, any other parent or guardian of the Participant and the Participant. As parent or guardian you recognize and agree that there are certain risks of physical injury or property loss to you and the below named minor Participant. You agree to assume the full risk of such injuries or property loss, which may include bodily injury or property damage as a result of participating in any and all activities associated with this program.

By signing below, the parent/guardian does hereby fully release and discharge the Municipalities and their officers, agents and employees from any and all claims regardless of form or theory, including, but not limited to claims for bodily injuries and property damage or loss which he/she or his/her minor child/ward may have or which may occur on account of participation in the Downers Grove Regional Peer Jury Program, including any claims of violations of confidentiality in regards to adjudication of the case.

**Parent/Guardian Indemnification and Defense of Municipalities.** By signing below, the parent/guardian does further agree to indemnify, hold harmless and defend the Municipalities and their officers, agents and employees from any and all claims regardless of form or theory, including, but not limited to claims for bodily injuries and property damage or loss which he/she or his/her minor child/ward may have or which may occur on account of participation in the Downers Grove Regional Peer Jury Program.

**Medical Assistance Authorization.** In the event of any emergency, the undersigned parent/guardian authorizes the Municipalities to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed reasonable and necessary for my minor child's immediate care and agree that I will be responsible for payment for all medical services rendered.
