PERMIT APPLICATION

- Complete a general permit application with all pertinent contractor information.
- Complete the electrical application, signed by the supervision electrician, and provide a copy of their municipal license, certificate of insurance and a \$10k Surety Bond.
- Complete the plumbing permit application, and provide a copy of the plumber's state contractor's license and a letter of intent.
- General Contractor will need to provide a certificate of insurance.
- Mechanical contractor will need to provide a certificate of insurance naming the Village of Willowbrook as certificate holder.
- If you are unsure of the subcontractors, you will be employing at the time you apply for permit, you may still submit your application. The Village will not issue a building permit however, until everyone working on your project has been identified.

SUBMITTAL REQUIREMENTS

- Submit FOUR (4) sets of drawings/sketches that indicate:
 - Existing and proposed floor plan with dimensions.
 - Indicate all existing and proposed wall modifications.
 - If any walls are being relocated or removed drawings must be prepared by an architect or structural engineer licensed in the State of Illinois.
 - Electrical plan including receptacles, lighting, switches, smoke detectors, and any other electrical appliances.

GENERAL REQUIREMENTS

- Two (2) dedicated 20-amp small appliance branch circuits required at the counters.
- The circuits supplying the outlets shall be arc fault protected.
- All kitchen counter receptacles shall be GFCI protected and tamper resistant.
- GFCI protection is required on the outlet that supplies the dishwasher.
- Receptacles required at peninsular counters and island counters.
- Counter receptacles shall be spaced so no point along the counter is more than 24" to receptacle. Receptacles shall be located within 24" of the edge of the sink, stove, refrigerator, and counter edge.
- The individual dwelling unit shall be equipped with carbon monoxide and smoke detectors located as required for new dwellings per the 2018 International Residential Code Sections R314.3.1 and Sections R315.2.
- The kitchen sink waste shall be 2".
- The kitchen exhaust fan shall discharge directly to the exterior.
- If the kitchen exhaust fan exceeds 400 CFM, a makeup air system is required & details shall be submitted for review and approval.






