The Primary Eligibility Register shall include candidate scores from the Initial Eligibility List, together with any claimed and approved preference points as provided in Section 5 of Chapter III of the Village of Willowbrook Board of Police Commissioners Rules and Regulations.

The Primary Eligibility Register shall remain valid for a period of two (2) years, after which it shall expire, and the Board shall strike all remaining names from the Register.

Prior to the expiration of the two-year period, candidates may be selected from the Primary Eligibility Register to participate in the oral interview process. Any individual whose name appears on the Primary Eligibility Register and who exceeds the age-thirty-five (35) requirement prior to appointment shall remain eligible for appointment until such time as the Register is exhausted or expires at the conclusion of the two-year period.
